You are aware that the Public Procurement Policy for Micro and Small Enterprises (MSEs) has been officially launched by Government of India from 1 April 2012. As per the Policy every Central Public Sector Enterprise (CPSEs) and Central Ministry/Departments are required to set an annual procurement target of 20% of total procurement from Micro and Small Enterprises apart from continuing to purchase 358 items already reserved for MSEs from 2012-13 onward.

A project in this regard has been undertaken to suggest methods of improving the effectiveness and efficiency with which Public Procurement Policy for MSEs will be implemented and also to create an information base for match making between CPSEs and MSEs.
