Dear ALL,

Department of Energy, Govt of UP on September 13, 2012 issued a notification announcing the rate of electricity duty for different categories of consumers. Copy of notification is attached herewith for the reference of IIA members.

We are getting feedback from our members that electricity supply companies are charging electricity duty on demand charges as well as on energy charges. As you must be aware that the electricity duty prior to this notification was applicable on units of electricity consumed only.

IIA understands that as per the notification dated September 13, 2012 electricity duty should only be applicable on energy charges and not on the demand charges. However the electricity supply companies are not agreeing with this.

Therefore we have submitted a representation before the Principal Secretary, Deptt of Energy, Govt of UP to clarify the component (Demand Charges or Energy Charges) on which the electricity duty is applicable as per the new notification and to direct the electricity supply companies to charge electricity duty only on energy charges.

NOTIFICATION

No. 1845 /XXIV-P-3-2012

In exercise of powers under section- 3 of U.P. Electricity (Duty) Act, 1952 (U.P. Act no.- 33 of 1952) and in supersession of Government notification no.-02-P-3/97-24-85P/84, dated January 03, 1997 and in modification of rates of Electricity duties fixed on various uses of electricity vide Government notification no-232 P-3/98-24-85P-84, dated February 06, 1998, the Governor is pleased to order that from the date of this notification the electricity duty shall be levied at the following rate :-

Sl. No.	Details of Consumption.	Determined rate of Electricity Duty (Value of Rate Charge %)
i	For residential lights and fan	5% of Rate Charge.
i	For Energy consumed by State Govt.	5% of Rate Charge.
ii	For purpose other than mentioned in items (i) and (ii) :	
	(a) For without meter supply on fixed Charge.	20% of Fixed Charge.
	(b) For metered supply	7.5% of Rate Charge.
v	For consumption in case of one part tariff where rate charge is based on units of consumption	9 paise per unit.
