Subject: Indian Industries Association (IIA) CEC Election Notice 2024-25 with the eligibility of vacancies.

Dear Members,

The Central Executive Committee (CEC) Election process for the year 2024-25 of Indian Industries Association for 7 (Seven) vacant seats from various Chapters/Division/Regions/States has commenced. The tenure of the Seven Elected CEC Members will be for 3 (three) years. As per IIA Rules & Regulations and data of paid members for FY 2023-24, a single constituency is calculated based on the total paid members as of 31st March 2024, fractionated by 21. The members required for one constituency for the year 2024-25 is $7497/21=357$.

Accordingly, membership of different chapters is clubbed where ever required to attain one constituency status and the details of CEC Member(s) for required Vacancies to be filled through this election are given below:

As such, the nominations for CEC Elections are invited from IIA members from the areas/chapters stated in the table above only.

For nomination in the CEC elections of IIA, only those members will be allowed to participate who satisfy the following eligibility criteria **for which an affidavit will be submitted along with the nomination form:**

- 1) Eligible Members shall be those whose Membership fee has been received by IIA Head Office till March 31, 2024 for the FY 2023-24. Any member who has not paid his membership fee in full for the FY- 2023-24 shall not be entitled to vote and file the nomination.
- 2) The candidate must have a minimum of 5 years of continuous membership of IIA.
- 3) The candidate must possess a valid MSME Entrepreneur Memorandum Part-II acknowledgment/ Udyog Aadhaar/Udyam Registration. **(Copy of the acknowledgment/ Udyog Aadhaar/Udyam Registration must be enclosed along with the nomination form).**
- 4) The candidate must have been an office bearer at the Chapter level/Divisional level/Central level having an exposure of CEC meetings at the Central level.
- 5) The candidate must have complete faith on IIA Constitution, Culture, and values and must not have indulged in any kind of anti-IIA activities at any point of time.
- 6) Employee other than Director in a Pvt. Ltd Company of a member enterprise will not be eligible for the Election as a CEC member of IIA.

Other applicable rules and regulations:

- a) Elected CEC members can be elected for a maximum of two terms. However, elected CEC Member will not be eligible for election for the consecutive term.
- b) Elected CEC Member will lose his / her status as CEC Member for remaining tenure (subject to the approval of President) in case his / her attendance in CEC Meeting in a year is less than 50%. For such remaining tenure, CEC may nominate/elect another senior member from the respective area / Chapter(s) and the criteria of minimum attendance will apply to such nominated members also.

The members may fill the nomination form and send it to **only** Election Officer's email address at annakut.biscuit@gmail.com or by post to **54-A, Dadanagar, Kanpur, Pin Code-208022, Uttar Pradesh.**, on or before the last date of the receipt of filled nomination forms, i.e., 16.04.2024. Any nomination received after the prescribed date will be summarily rejected. IIA Election notice has been uploaded on the IIA website (www.iiaonline.in), and is also sent to IIA Chapter's Chairpersons for informing every eligible member in the respective chapter. Election Notice will be sent through email to all IIA members. IIA members will be informed through IIA WhatsApp Groups including IIA DAAK WhatsApp Broadcast about the election process.
