WHEREAS, both IIA and ClubNPC are committed to the holistic development of society, economic empowerment, and sustainable community initiatives;

AND WHEREAS, both parties recognize the value of mutual cooperation in initiatives that promote entrepreneurship, environment, education, skill development, Innovation, social responsibility, and community welfare;

7. Termination

Either party may terminate this MoU by providing a 30-day written notice to the other party. All ongoing activities will be concluded in a mutually agreed manner.

8. Amendments

This MoU may be amended only through a written agreement signed by both parties.
