Dispute
Resolution
Mechanism

In case any difference arises in implementation of any clause or terms of conditions of this MoU, the same can be amended by written MoU between the parties at the first instance. However, in the event such difference/dispute cannot be resolved mutually between the parties hereto within a period of 90 days from the date of notice of such issue, the same shall be submitted to the provisions of the Arbitration and Conciliation Act, 1996 as amended from time to time and the place of arbitration shall be New Delhi and the proceedings will be held in English language. This MOUs governed by the laws of Union of India and jurisdiction for any legal proceedings shall be New Delhi.

Article XI Execution

This MoU shall be executed in duplicate and each Participant shall retain a copy of the same.
