Memorandum of Understanding (MoU)

This MoU is made and executed on this 3rd day of April, 2026, at Arunachal University of Studies, Knowledge City, Namsai, Arunachal Pradesh.

BETWEEN

The University Industry Interlinkage Centre (UIILC) of Arunachal University of Studies (AUS), Namsai, Arunachal Pradesh, the extreme Eastern University of India often called as University of Rising Sun in India, a State University under Self-Sponsored category established vide the Arunachal Pradesh Act, 2012 (No. 9 of 2012), hereinafter referred to as "AUS".

AND

IIA, having its registered office at IIA Bhawan, Vibhuti Khand, Gomti Nagar, Lucknow - 226010, hereinafter referred to as "Indian Industries Association" (which expression shall, unless repugnant to the context, include its successors and assigns)

PREAMBLE

Whereas, AUS is committed to promoting academic excellence, research, innovation, and socio-economic development in the State of Arunachal Pradesh;

Whereas, IIA is engaged in consultancy and is interested in exploring business, investment, and development opportunities;

Whereas, both parties recognize the potential of Arunachal Pradesh as an emerging hub for business, industry, and sustainable development;

Now, therefore, both parties agree to collaborate under this MoU to facilitate exploration and development of business opportunities in Arunachal Pradesh.

OBJECTIVES

The primary objectives of this MoU are:

1. To assist IIA in exploring business and investment opportunities in Arunachal Pradesh.
2. To provide academic, research, and institutional support through AUS.
3. To facilitate networking with local stakeholders, government bodies, and industry partners.
4. To promote sustainable and inclusive development initiatives in the region.

SCOPE OF COLLABORATION

AUS shall:

- Provide guidance, institutional support, and relevant information about the socio-economic landscape of Arunachal Pradesh.
- Facilitate meetings with government departments, local authorities, and industry representatives.
- Assist in conducting feasibility studies, research, and field surveys where required.

- Support skill development, training, and capacity-building initiatives aligned with proposed business activities.

IIA shall:

- Explore and identify viable business and investment opportunities in the State.
- Share project proposals, plans, and areas of interest with AUS.
- Comply with all applicable laws, policies, and regulations of the Government of Arunachal Pradesh.
- Work towards sustainable and ethical business practices.

INVESTMENT COMMITMENT BY IIA Ho

IIA expresses its intent to explore and undertake potential investments in Arunachal Pradesh across identified sectors such as infrastructure, education, tourism, skill development, or other mutually agreed areas. Subject to feasibility studies, regulatory approvals, and internal evaluations, IIA may invest financial, technical, and managerial resources for establishing projects, joint ventures, or development initiatives in the State. Such investments shall aim to contribute to economic growth, employment generation, and sustainable development of Arunachal Pradesh, in alignment with the policies and guidelines of the Government of Arunachal Pradesh.

DURATION

This MoU shall remain valid for a period of five years, effective from the date of signing, and may be extended upon mutual consent.

CONFIDENTIALITY

Both parties agree to maintain confidentiality of any proprietary or sensitive information shared during the course of this collaboration.

TERMINATION

This MoU may be terminated by either party by giving 30 days' prior written notice to the other party.

AMENDMENTS

Any amendments or modifications to this MoU shall be made in writing and signed by both parties.


NON-BINDING NATURE


