A High Powered Business Delegation led by President H.E Mr Yahya Al-e-Eshagh, Tehran Chamber of Commerce Industries and Mines(TCCIM) is visiting India in the month of May and FIEO has organized a B2B meetings on May 7, 2012 at New Delhi and May 9, 2012 at Mumbai.

New Delhi

Iran is a challenging market with excellent business opportunities for a large number of Indian goods and services. During 2010-11, Indian exports to Iran amounted to USD 2.7 billion, registering an increase of 49% despite banking uncertainties.

With the recent activation of Rupee arrangement by the two Governments, Indian exporters are assured of receiving payments through the designated Banks - Parsian Bank in Iran and UCO Bank in India. The Indian exports should strictly confine to non-UN sanctioned products and categories, as India is committed to UN sanctions. As per the recent notification issued by DGFT, exports to Iran realized in Indian rupees will also be eligible for export benefits and incentives, at par with export proceeds realized in freely convertible currency.

The delegation will include Iranian businessmen from the following sectors:

Oil and Gas Petrochemicals

Food items (Tea, rice, wheat, meat, corn, sugar, cooking oil) Textiles and clothing

Pharmaceutical, Drugs, Medical Equipment Saffron, Gold and Jewellery

Zinc and Lead, Steel, Plastic, Engineering and Technical Services,

Automobile spare parts Paper and carton

Wire and Cable, Metallurgy Aluminium, Rubber and Tyre,

Shipping and Ports Banking

Senior officials from Ministry of Commerce, External Affairs, Embassy of Iran in New Delhi, UCO bank, Reserve Bank of India, ECGC etc. will also be present
