### Protest on increase in Electricity Tariff - Actions requested at Chapter levels (Bulitin-22.10.2012)

To, IIA Chapter Chairpersons,

Dear Colleagues,

Greetings from VU3S,

Kindly refer to the e-mail as reproduced below sent to you yesterday wherein you are informed that a "Vidyut Upbhokta Sanyukt Sanghash Samiti" (VU3S)has been constituted at the State level with the initiatives of IIA to fight the atrocities being imposed on Industrial and Commercial Electrical Consumers by the Regulators as well as the Government. I am happy to inform you that the VU3S have started functioning and following immediate action plan has been planned wherein your co-operation and the co-operation of IIA Members as well as other Industry & Trade Associations will be essentially required to achieve our aim of getting the Electricity Rate increase rolled back:

- 1. On 26<sup>th</sup> October 2012 the State level VU3S will hold Dharna and Procession at Gandhi Pratima Near GPO, Lucknow wherein Heads of all the constituents Associations and their members will assemble in large numbers and a Demand Letter will be handed over to the Chief Minister Uttar Pradesh.
- 2. All IIA Chapters will also invite local/ regional/State Heads of other Industry / Trade / Electrical Consumer Associations to join the VU3S at State Level . IIA Chapters and other associations will submit the Demand Letter to Chief Minister U.P through respective District magistrate. ( Draft of the Demand letter will be provided by tomorrow to all the Chapters).
- 3. In case our demands are not met within one week, State level Bandh of all Industrial and commercial establishments will be organized for which the line of action will be communicated at appropriate time. However, in the meantime, Industrialists and Traders are to be sensitized to be ready for this eventuality / sacrifice.
- 4. VU3S is also exploring the legal remedy for which expert advise is being taken.

Your suggestions to strengthen this movement and make it a success are invited as early as possible.

Dear All,

It is to inform you that IIA alongwith other Electrical Consumer Associations have decided to protest against the Electricity Tariff hick announced by UPERC on 19<sup>th</sup> Oct. 2012. In this process a press note was released on 20<sup>th</sup> Oct. 2012 which has already been mailed to you.

Today i.e. 21 Oct. 2012 a Press Conference was organized at IIA Bhawan, Vibhuti Khand Gomti Nagar, Lucknow which was addressed by heads of 17 different associations. The press note issued to the Media on this occasion is attached herewith. On this occasion a Joint Action Committee has also been constituted at the State level to fight for the cause in future.

It is advised that all IIA Chapters should also organized such Press Conference immediately preferably on 22<sup>nd</sup> October 2012 on the lines stated in the Press Note at respective chapters.

The Joint action committee headed by Shri G.C. Chaturvedi as its chairman have decided that on 26 Oct.2012, 12 noon all constituents associations of the joint action committee will organized a Dharna & Road March from Gandhi Park Lucknow & will handover a memorandum to the Chief Minister, U.P. All IIA Chapters will also hold Dharna & Road March in respective Distt. on 26<sup>th</sup> October 2012 and handover the memorandum to the Chief Minister through respective DM's. The Draft of the Memorandum will be sent to all the Chapter by 23<sup>rd</sup> Oct. 2012.
