#### **CONCLAVE HIGHLIGHTS**

- Green Energy Business Conclave was inaugurated by Shri Mahesh Kumar Gupta (IAS), Additional Chief Secretary Energy & Renewable Energy Uttar Pradesh and Shri Anupam Shukla (IAS), Director UPNEDA was present as Guest Of Honour.
- 10 reputed solar companies showcased their quality products and services in the Conclave.
- The conclave provided ample networking opportunities for more than 150 delegate to connect with industry experts, and potential

partners.

Renowned speakers from the renewable energy sector delivered keynote addresses on the

importance of solar energy adoption and its impact on sustainable development.

#### The Inaugural Session

In the inaugural session of the conclave, chief guest Shri Mahesh Kumar Gupta (IAS), Additional Chief Secretary Energy &



Renewable Energy Uttar Pradesh said that ever since the state government has promulgated the new Solar Energy Policy-2022 and Bio Energy Policy-2022, encouraging investment proposals have been received in solar energy, out of which about 16 percent proposals have been implemented on the ground. Shri Gupta called upon IIA and the entrepreneurs present at the Conclave to establish solar and bio energy hybrid energy production plants in the rural areas of the state, which have immense potential.



National President of IIA, Shri Neeraj Singhal said in his address that we have to take the industries towards decarbonization and provide them the benefit of carbon credit. For this, IIA has decided that entrepreneurs



will be encouraged to set up solar power plants in 15 industrial areas in Uttar Pradesh. This campaign has been started by IIA from Shamli Industrial Area where 8.5 MW solar power plants are being installed by IIA members. According to the survey conducted by IIA so far, the members have expressed their desire to set up 28 MW solar power plants. In this effort, IIA in collaboration with UPNEDA is also organizing workshops in various districts. Till now 6 such workshops have been organized. National President Shri Neeraj Singhal said in his address that there is immense potential for solar energy production in the industrial areas of the state. In 154 industrial areas of UPSIDA, industries are established on 46660 acres of land. If the target is set to establish roof top solar plants on 25 percent of this land, then we will have 11000 acres of area available in which production of several gigawatts of solar power is possible.

To achieve this goal, President IIA suggested that the limit for **obtaining solar power through open access should be reduced to 100 KW from the current 1 MW**, net metering facilities should be provided to micro scale industries and they should be

allowed to install solar power plants like domestic consumers & Subsidy should be given to do so. Virtual net metering system for solar power generation and usage should be implemented as has been done by the Delhi government, Mr. Singhal said.





address that the state government has decided to install solar power plants in all government buildings and educational institutions, for which net metering system has been implemented and solar power plants can also be installed on RESCO model. Shri Shukla said that the procedures for setting up solar power plants have also been simplified. In the future, the problems that the consumers were facing at present will no longer be there.

On the occasion of the inauguration of the conclave, the chief guest, special guests, experts, sponsors and participants were welcomed by Mr. Alok Aggarwal, General Secretary IIA. Shri Tariq Hasan Naqvi Chairman IIA Renewal and Bioenergy Committee informed the participants about the outline of the conclave. Shri Awadhesh Aggarwal, National Treasurer IIA presented the vote of thanks and presented mementos to the guests.
