









Labour code reform

- Total 3773 compliances of 60+ departments have been reduced as part of RCB 1 & RCB 2.0 initiative
- UP has **successfully minimized 100% self identified compliances** without any fail
- Total 907 Acts/Regulations/Rules of 27 departments have been abolished in Uttar Pradesh
- Total 568 compliances have been decriminalized through providing compounding options especially into Labour/legal metrology/Transport dept.
- 4 key licenses registrations (Trade License/Hotel/Travel agency/Professional Tax related License) have been abolished now
- More than 10 renewals under more than 7 depts. have been abolished for key licences e.g., Drug –Retail/wholesale/manufacturing, IT Dept for Mobile tower installation renewals; Commercial tax, Film Bandhu, Tourism dept and within Legal metrology dept. etc.
- More than 27 types of Renewals already allowed on Auto renewal basis (within PCB/FSDA/Legal Metrology/Labour & Urban dept.)
- More than 5 approvals are based on Self certification (Within Consent to Establish & Operate-PCB/Renewal of registered label approval in Excise/Labour dept. etc.)
- Certain licenses have been merged in UP e.g., Brand and Label registration, Consent to Operate with Hazardous license in PCB

UP has successfully notified all 4 Labour Codes including Occupational, Safety & Health(OSH) Code in 2022 well before BRAP 2022 deadline

Destination Uttar Pradesh IT Sector

- Uttar Pradesh (UP), as India's largest labour market, is known as the IT Hub of North India
- → State holds 6th position in software exports in India
- The state currently has operational IT parks in Noida, Meerut, Lucknow, Kanpur and Prayagraj. Another IT Park in Agra will shortly become operational. Three other parks are being developed in Varanasi, Bareilly, and Gorakhpur cities
- ✓ IT City, Lucknow: A SEZ developed by HCL Group with an investment of US\$ 78 Mn with a direct employment of 5900. It is based on the Walk to Work concept such that 60% of the total area i.e., to be used for IT &ITeS activities and the balance for commercial, residential, health and education
- ✓ Under the UP IT/ ITeS Policy 2017-22, the state received investment proposals of around US\$ 765 Mn with employment of ~53,000 people






